Dear Chapter Members,

This year the Chapter has scheduled (2) half-day hunt. The dates are Saturday in the afternoon of January 21st 2011 and Sunday in the morning of February 26th 2011 at **Bent Creek Hunting Preserve**. HUNT COSTS

1. The cost is \$105.00 per person per hunt; this includes coffee, soda, and the stocking of 6 birds per person, of any combination, pheasant or chuckers. Please note that coffee and the soda, will be served at 12:00 PM, on January 21st 2012 and the hunt will commence at 1:00 PM.
2. The hunt for February 26th 2012 is in the morning. Please note that coffee, donuts and soda, will be served at 7:30 AM and the hunt will commence at 8:30 AM.
3. **The hunt reservations must be paid in full prior to the day of the hunt. Therefore, Tim Clark must receive your reservation and payment for the January 21st hunt no later than December 21st 2011, and your payment for the February 26th hunt no later than January 26th 2012.**
4. **We must have a minimum of 16 hunters and no more than 24 hunters. The hunters can be club members, or guests, a max of two guests per club member. This is on a "first come first serve basis", so get your reservation into Tim Clark. Last year this hunt filled up fast.**
5. We must have four people in each field, so if you know the four people that you will be hunting with please e-mail Tim Clark with that information, his e-mail address is vctref@comcast.net
6. There will be some type of raffle or prize awarded to one participant. No money bird this year.

HUNT RULES

1. It is the Preserve's policy that hunting parties must contain a maximum of 4 hunters. You will be able to hunt 4 dogs per group. You must have a 2012 NJ hunting license or you can buy a one day license at Bent Creek
2. The taking of rabbits and/or migratory game is illegal. Please abide by State and Federal Game Laws.
3. There will be a stocking of 6 birds per hunter. Once you or your party bags its limit, you can not shoot any more birds but you can still run you dog/dogs.
I hope you are having a safe and successful season and will be able to attend the club hunts.
